

PUBLIC NOTICE

Route Modifications Public Hearing

NOTICE IS HEREBY GIVEN that the Kings County Area Public Transit Agency (KCAPTA) will hold two public hearings to seek comments from the public regarding the proposed transit modifications that will impact both the fixed route and paratransit services.

The transit system operated as Kings Area Rural Transit (KART) proposes the following modifications:

- **ROUTE 4 HANFORD**, DELETE THE FOLLOWING STOPS:
 - STOP 5 – 10TH AVENUE & FAIRGROUNDS
 - STOP 6 – 10TH AVENUE & CITY YARD
 - STOP 8 – 10TH AVENUE & ORCHARD DRIVE
- **ROUTE 6 HANFORD**, CHANGE TO LEAVE ON THE HOUR AND ON THE HALF HOUR
- **ROUTE 8 HANFORD**, DELETE THE FOLLOWING STOPS:
 - STOP 8 – HANFORD ARMONA ROAD @ RAILROAD
 - STOP 11 – 10TH AVENUE @ TAPITIA BAKERY
 - STOP 12 – 10TH AVENUE & ORCHARD DRIVE
- **ROUTE 12 AVENAL**, DELETE ALL STOPS IN LEMOORE ON THIS ROUTE EXCEPT THE FOLLOWING:
 - 18TH AVENUE @ PIZZA HUT
 - WEST HILLS COLLEGE
 - HANFORD ARMONA ROAD @ KMART
 - BUSH @ DAVITA DIALYSIS
- **ROUTE 15 VISALIA**, DELETE ALL STOPS IN VISALIA EXCEPT THE FOLLOWING:
 - COS VISALIA CAMPUS
- **ROUTE 17 FRESNO**, DELETE THE FOLLOWING STOPS:
 - STOP 2 – DEWOODY @ POST OFFICE
 - STOP 7 – FRESNO @ SHAW
 - STOP 8 – FRESNO @ KAISER HOSPITAL
- **ROUTE 17 FRESNO**, ADD THE FOLLOWING STOP:
 - PROPOSED STOP TO THE FRESNO YOSEMITE AIRPORT

BUS FARE CHANGES

- ELIMINATE THE 30 DAY PARATRANSIT BUS PASS

MISCELLANEOUS SYSTEM CHANGES

- CHANGE THE HOLIDAY SCHEDULE TO:
 - OPERATE A REGULAR SCHEDULE ON THE DAY AFTER THANKSGIVING
- CHANGE THE INFORMATION WINDOW HOURS AT THE BUS TERMINAL TO:
 - MONDAY THRU FRIDAY 7 AM TO 7 PM
 - SATURDAYS 9 AM TO 2 PM
- ADD A FLEX ROUTE TO OPERATE 7:00 PM TO 9:00 PM MONDAY THRU FRIDAY WITHIN THE HANFORD SERVICE AREA
